A. RELATIONSHIP: Father/Son

- B. CASE SUMMARY: On May 6, 2003, the victim, the suspect, and three children were present in their apartment. The victim's mother, suspect's girlfriend, was beaten by the suspect. She locked herself in the bathroom to prevent further beating. When she exited the bathroom, she found the victim dead and her 16-month-old child severely beaten by the suspect. The suspect fled with her five-year-old son, who is not the suspect's child. The suspect drove the five-year-old to another city where he left the child with relatives. The police later arrested the suspect and charged him with first degree murder. The case is pending.
- C. <u>CHILDREN</u>: The homicide victim was 5-months-old. Both a 16-month-old girl and a 5-year-old boy were present in the home during the murder. The 16-month-old girl received severe injuries, but is recovering.

After the homicide, the victim's aunt reported to the police that three days earlier, the suspect had threatened to "snap" her children's necks and kill both her and the victim's mother.

#### I. CRIME

- A. <u>RELATIONSHIP</u>: 1) Wife of suspect, 2) Brother-in-law of suspect, 3) Father-in-law of suspect
- B. <u>CASE SUMMARY</u>: The suspect, the victim, and the victim's brother all lived together. The suspect shot his wife in the head on May 14, 2003 during an argument. The suspect then hid victim #1's body under a pile of clothing. Later the same day, he shot victim #2 in the head when he came home and started looking for the victim. The suspect then hid victim #2's body under some clothing and furniture. A few days later, when victim #1 and #2's father (victim #3), came looking for them, he was shot in the head by the suspect and was hidden in a similar manner. Some days later, the victim's boyfriend came over to the residence and was shot. His body was hidden like the others. The fifth victim was a neighbor who came over to sell the suspect some drugs. He was shot and his body left in the open on a bedroom floor covered by a small sheet. A friend who visited with the suspect called police and reported a foul odor. Patrol responded and the suspect held his 4-year-old son hostage while armed and threatening suicide. SWAT was called and eventually the suspect released his son and surrendered after a 12-hour standoff. The suspect was charged with 5 counts of murder. The case is pending.
- C. <u>CHILDREN</u>: Neither of the suspect's two children witnessed the shootings; however, they were on the premises during this time. After the suspect shot the first three victims, he arranged for his 11-year-old stepdaughter to stay with her biological father. His 4-year-old son with victim #1 continued to live in the home until he was released one-and-a-half weeks later.

The suspect then called 911 and said he killed his wife. The suspect was found guilty of murder and sentenced to life.

- B. CASE SUMMARY: On June 23, 2003, the suspect apparently waited for her husband to go to sleep and then shot him as he was laying in bed. She then called her son-in-law to come to the home. When the son-in-law arrived he found a note on the door from the suspect. After making the phone call, the suspect apparently laid down beside the victim and shot herself in the head. The suspect left several notes behind indicating she was depressed and did not want to leave her husband behind. The victim had been suffering from depression for some time and recently quit taking her medication.

#### 1. **CRIME**

A. **RELATIONSHIP:** Estranged Boyfriend/Girlfriend

- B. CASE SUMMARY: Police were called on June 25, 2003 to the residence once shared by the victim and the suspect in reference to a shooting. Upon arrival the victim was found in the yard at a near-by residence. The victim had a gunshot wound to the chest. The investigation revealed that the victim forced his way into his estranged girlfriend's locked residence, in an attempt to commit a battery on the suspect, and was subsequently shot. He retreated from the residence and was helped across a fence to another residence where he collapsed on the ground. The victim was transported to Shands Hospital where he died from his injuries. Preliminary indications are that the shooting was justified. A witness stated that the victim was drinking beer at her home earlier in the evening. The case is cleared/justifiable homicide. Eight months later, the suspect committed suicide.
- CHILDREN PRESENT: The suspect had a 17 year old daughter living with her who C. was present during the homicide. They do not have children together.

A. <u>RELATIONSHIP</u>: Wife/Husband, separated

B. CASE SUMMARY: On July 11, 2003, the victim left the suspect intending to get a divorce and moved in with a friend where the suspect could not find her. The same day she petitioned for an Injunction for Protection from the suspect due to previous domestic violence. On July 12th or 13th, the victim's sister brought the husband to the location where the victim was staying in hopes of facilitating a reconciliation. On July 16, 2003, the suspect drove to the apartment where his wife was staying, bringing a ladder. He climbed onto the balcony of the second floor apartment and broke the sliding glass door with a piece of concrete and entered the apartment with a sawed-off double barrel shotgun. He moved past the friend and sister and shot the victim twice, reloaded and turned the gun on himself. Both were dead at the

The suspect was arrested for carrying a concealed weapon on 09/06/95 and, according to petitioner had threatened her with a gun in the past. Though victim advocates are available to meet with most petitioners to safety plan at the time of obtaining the injunction, current staffing levels mean they cannot meet with every victim. Injunction paperwork indicates potential lethality factors but no advocate was available to meet with the victim to safety plan. A family member underestimated the potential lethality and revealed the victim's hiding place to the suspect.

The suspect failed to enroll in Batterers' Intervention Program when ordered. There was a violation of probation completed. The suspect's probation was revoked and set aside on 09/11/97. He served 29 days in county jail and was not ordered to re-enroll in Batterers' Intervention Program.

- B. <u>CASE SUMMARY</u>: On October 18, 2003, the victim and suspect were arguing. The suspect began to choke the victim as he has done in the past. When the suspect realized that the victim was not breathing, he cut her throat with a pocket knife. The suspect placed the victim in the bathtub and began cutting her up with a saw and using a hammer to break the bones. The suspect placed the different parts of her torso in bags and put the bags around a wooded area. The suspect confessed to the killing after some of the victim's remains were found. A. <u>RELATIONSHIP</u>: Girlfriend/Boyfriend (former co-habitants)

- B. <u>CASE SUMMARY</u>: The body of an unknown black female was found in a park. The victim had been shot in the head. Witnesses reported they heard a single gunshot the night before and then saw three young black males flee from the park to a vehicle that was parked outside the fenced area of the park. The victim was subsequently identified by her ex-husband. The primary suspect was identified as the victim's ex-boyfriend who she once lived with in Arizona. The suspect's co-defendants were 17 and 18-year-old brothers and were friends of the suspect. They also sold drugs for the suspect. The suspects lured the victim to the park under the cover of darkness intending to kill her because the victim had obtained an Injunction for Protection and was proceeding forward in prosecuting the primary suspect for domestic battery. The suspect has been charged with murder. The case is pending.

When the police arrived, they found the victim unconscious. The victim was transported to the hospital where she was pronounced dead. The suspect was apprehended and arrested on an outstanding warrant. The suspect admitted hitting the victim with a shotgun and his fists. The cause of death was listed in the autopsy as homicide by blunt trauma to the abdomen. The suspect was charged with second degree murder and the case is pending.

## **CONCLUSIONS**

(1997 - 2003)

In 2003, the number of domestic homicides remained consistent with the average number over the years of our review. The majority of these homicides involve intimate partners, as with domestic violence cases in general.

In 69% of these homicide cases, there were no prior police or social service involvement. Awareness needs to be raised within community agencies and the community as a whole about domestic violence and the importance of intervention.

The committee continues to note several mental health issues in our reviews. Many suspects talked with family, friends, and co-workers about suicide before the murders. Depression and suicidal ideations are clearly red flags and lethality indicators in cases of domestic violence. More community awareness about mental health issues and appropriate intervention is needed. Additionally, we note the need for more information sharing between criminal courts and civil proceedings concerning Baker Acts and other civil commitment actions.


The committee is still concerned that not enough batterers are ordered into statutorily mandated state certified batterers' intervention programs (BIP). It is imperative for the justice system to hold batterers accountable. Perpetrators need to be held accountable when they do not successfully complete BIP. Ninety percent (90%) of participants who complete the program are not re-arrested in the next three years.

HARK is still being under utilized. There were 24 cases where suspects had prior domestic violence arrests, yet of all the cases reviewed, there have only been two HARK referrals. Our community and the agencies involved here should make intervention for these children a high priority.


After a careful review of these homicide cases, the committee feels strongly that those working in the legal system need training about the dynamics of domestic violence and the effectiveness of intervention.


# Race and Gender of Domestic Homicide Victims




# **Age of Domestic Homicide Victims**



# **Relationship Status of Intimate Homicides**










