2011 Domestic Violence Homicides

This summary provides basic information about domestic violence homicides in Wisconsin during 2011. The statistics and names below can in no way represent the victims' full lives or measure the extent or depth of the loss. The information is provided to honor the victims and call further attention to the continuing need to reduce and eliminate domestic violence in Wisconsin.

For the purposes of this summary, homicides were considered "domestic" if the victims and perpetrators were spouses or partners, former spouses or former partners, adults with children in common, adults or teens who had been in a dating relationship, or adult family members (e.g., parents killed by an adult child). Homicides of others were also included if the circumstances of the murder included a perpetrator's attack on someone connected with a current or former partner, such as a new partner or friend or family member. The report also includes homicides of domestic violence perpetrators that occur as their victims acted in self-defense, as well as those that occurred as a result of legal intervention. Information in the summary is gathered from news reports, uniform crime reports, publically available information, such as criminal complaints, and information from local domestic violence victim service providers.

[†]Antonio Gill was found not guilty in February 2012. He was accused of killing Nash, his sister's boyfriend, after the sister and boyfriend were involved in a series of verbal and physical arguments. Gill's defense at trial was that his sister killed Nash. Thus, the homicide is classified as domestic no matter who killed Nash. The sister has never been charged, and therefore, Gill remains listed as the perpetrator in this summary.
